The bids will be awarded individually, and it is not necessary to bid all of the unit(s).

The sealed bids marked "**Small Pontoon Boats**" **BID ID#:2013-0009** must be received no later than 3:00 PM, Tuesday, January 14, 2014 in the Forest Preserve Office, 1504 3rd Ave., 2nd Floor, Rock Island, IL 61201. The bids will be publicly opened and read aloud immediately thereafter. Only bids using the enclosed proposal forms will be considered.
