2. Engine: gasoline 5.3 L V-8 (minimum) with electronic fuel injection or alternative high efficiency mileage engines that accommodate the other specifications throughout.
3. Minimum Transmission: 4 –speed automatic over-drive
4. Differential: Posi-Traction Type, 3.73 Axle Ratio
5. Four-wheel drive with automatic locking and unlocking hubs and push button control
6. Fresh air heater and defroster
7. Bucket cloth seats, heavy duty foam
8. Power controlled exterior mirrors - trailering, high visibility vertical, manual folding and extendable, with convex spotter glass.
