There was general consensus that staff could contact the owner and have a conversation about the purchase.

Mr. Craver concluded by stating that the City of Rock Island had the discussion of the purchase of the previously discussed wet land property at their meeting this month. There appear to be no issues or concerns with the land.

Weather conditions—Weather conditions have been nice with cooler evenings and daytime highs in the mid 70's.

Activities/Events/Outings held at park— We hosted the fall Illinois City Saddle Club Horse Show early this month.

Volunteer Hours--I have no volunteer hours to report for the month of October.

October was a very busy month here at Loud Thunder. The fall colors hit their peak around mid-month and brought out dozens of people to look, take pictures, and picnic while enjoying the beautiful canopy. Campers continued to patronize the preserve until the very last day of camping due to the extremely nice weather we had during the month. Trail usage was up significantly for the month of October as I was able to keep trails open and staff were able to make some big improvements on several creek crossings out on the South Sac Fox loop.

David Wyffles with the IL DNR Fisheries came out to do a survey on the crappie population in Lake George in the last week of October. He and other Fisheries staff netted and analyzed crappies for two days. At the conclusion of this site visit, he mentioned that there will possibly be future harvest regulation information to put out to the public to improve the population in Lake George. At this point in time he had no concerns with Lake George.

Of the two-bee hives that I have here at the preserve one of them is thriving. The second hive seems to have abandoned their home or absconded. This spring staff will prep the abandoned hive and also rehab a hive that was donated to the preserve so Loud Thunder will be going into the 2023 season with 3 healthy bee hives. The honey that staff have harvested seems to be a very big seller in the office and the pollination benefits that we are seeing in our prairies has been very encouraging over the past two years since we started being a site for bees.

I applied for a grant from the Rock Island Soil and Water Conservation District to receive 25 rpm oak trees. If awarded the trees I will be planting them in our new equestrian campground area. I will also be placing signage to help educate the public on the value of these native trees and to assist them with identification. I will inform this committee on the outcome of this application moving forward.

As I mentioned earlier in this report, the Illinois City Saddle Club held their annual fall horse show early in the month. Staff tilled the corral twice to ensure that the arena was in the best condition that we could possibly get it for this event. We mowed the area closer to the day of the show to give this area a fresher look than it typically would during that time of the week, and staff spent extra time cleaning the rest rooms. Hopefully, all these little things helped the club to hold an awesome event. Unfortunately, I was out of town with my son for youth season shotgun season so I was not able to get out and get feedback from the club that day.

I will be reaching out to the Highway Department to help me address a few things noted on our last inspection of the Lake George Spillway. The majority of what I will need help with is filling in some erosion and burrow holes on the downward side of the dam. I would like to have these addressed prior to going into the winter season as IMEG will be conducting another inspection this spring, and I would like to have this checked off the discrepancy list prior to that inspection.

Blackhawk highway career construction training program (BHCCTP) members did some work here for the month of October. The students came out and poured two dumpster pads for the preserve which really help to make the dumpster areas much more aesthetically pleasing. I really can't say enough good things about the partnership that I have been able to build with Paul Fessler and this program. Loud Thunder has benefited substantially from the projects that the HCCTP students have completed for the preserve. Thank you for allowing me to work with this group and your continued support for this program as it is saving the district significant amounts of money and greatly enhancing the infrastructure of Loud Thunder Forest Preserve.

Joshua Sun, the organizer of the LT50 race has sent me a request for permission, attached, from this committee to hold his race again next April in 2023. It is my recommendation that this committee approve this request as Josh has proven that he runs a great event and he has donated monies back to the preserve after both of his previous races. He and his group have donated over \$2,500 to Loud Thunder in just two years and they leave Loud Thunder looking clean and undisturbed when their event is over.

My name is Joshua Sun and I am submitting a proposal to host a trail running event at Loud Thunder Forest Preserve scheduled for Saturday April 15th pending the commission's approval.

This will be our 3rd annual event and we have had great success both previous years with runners enjoying a beautiful and challenging day of trail running all while raising \$3,500 in just those two years for the park.

We are seeking approval to once again host a small, low key trail race offering 50mi, 50k and half marathon distances on Saturday April 15th 2023. 2023 Tree Planting Initiative – Request for proposals

2023 Goal: Plant 850 container trees throughout Illinois communities!

Rock Island Soil & Water Conservation District is looking for an upland site to plant 25 4' RPM oak trees – approximately $\frac{3}{4}$ acre. The site must be on public property such as public parks, nature trails, conservation areas, schools or other public property.

This is a community partnership project funded by the Illinois Forestry Development Council, University of Illinois Extension 4-H Foundation and Association of Illinois Soil & Water Conservation Districts.

Additionally, the purpose of this year's project is to educate students, teachers, and their communities on the value of native oak savannas and trees to Illinois natural history, oaks as a keystone species in Illinois forests, tree planting techniques, and oak tree identification.

Rock Island Soil & Water will coordinate pick-up and delivery of the trees to the site. Extension 4-H kids will be planting the trees on a specified date TBD in early April with assistance from Extension and Rock Island Soil & Water staff. Rock Island Soil & Water will also provide tree tubes and stakes for all 25 trees and signage for the site. Trees provided include: 10 White Oak; 5 Red Oak; 5 Black Oak and 5 Bur Oak.

Notes & updates from prior Forest Preserve Executive Committee Meetings

The District's appropriation & tax levy ordinance and Truth-In-Taxation certificate have been filed with County Clerk's Office.

City of Rock Island acquired the property near Bally's Casino in Rock Island and is in the process of annexing the property into the City. Once the City completes the annexation, the District expects City officials to contact the District about transferring portions of the property to the District.

Another public hearing about the I-80 bridge and transportation corridor was held October 27th. Enclosed is the newsletter about that meeting for your review. The District is specifically interested in the I-88 interchange as Alt A & B will impact Amôwa Forest Preserve. I highly doubt Alt D will be considered due to costs and higher environmental impacts than the other alternates. Another impact of a new bridge construction is the bike path being closed or altered in some form. More information can be found at <https://www.i80mississippibridge.com/>

With the camping season at its end, staff will begin winter preparations such as turning water off throughout the parks and winterizing other plumbing. Certain areas of the parks will be closed to vehicular traffic come the middle of December or earlier weather permitting. The parks are equipped with the ability to plow snow but not spread salt. The past several winters and springs continue to be very hard on the roads throughout the District especially at the parks as they were not constructed for the current capacity of patrons on a 12-month basis.

The zoo closed for the season after the two-day Boo at the Zoo activity.

The golf course will continue to operate, but play has significantly slowed due to frost in the mornings and when daytime high's do not exceed 50 degrees.

No Transfers of Appropriation were required in any fund of the District as appropriations are currently in-line with the amounts adopted.

Resolution

There are three resolutions to consider this month and all three pertaining to grants and appropriations for those grants. At this time the appropriations pertain to the design portions of the projects for the Prairie Dog Exhibit, African Painted Dog Exhibit and Illiniwek Grand Illinois Trail and Support Facility.

Ordinances

There are two abatement ordinances pertaining to the existing bonds the District has acquired in prior years. These abatements are done annually at this time of the year as funds from the General Fund and Niabi Zoo Fund property tax received along with earned revenues are used to make the scheduled payments. A specific levy to ensure payment of the bonds was written into the adoption of the bond ordinances and these abatement ordinances stop that levy from going into effect for taxes levied in 2022 to be payable in 2023. Upon approval they will be filed with the County Clerk's Office.

Other Business

Consider bids received for the Niabi Zoo Prairie Dog Exhibit. Two bids were received from local contractors, Estes Construction and The Henley Group. The Niabi Zoo Prairie Dog Exhibit is being funded through the Illinois Public Museum Grant program and the grant is a reimbursable grant in the amount of \$436,100. The apparent low bidder is The Henley Group from Muscatine, IA. An addendum for an exhibit structure was added after the grant was submitted. Total project cost is approaching \$582,500 or \$655,500 if accepting the addendum. Use of unappropriated funds within the Zoo Fund will most likely create short-term cash flow issues for the Zoo Fund in 2023 and likely into 2024.

Reports

Budget Performance Report for FY 23. October was a solid month throughout the District in terms of revenue generation. When looking at the calendar year some numbers fell behind last year's record numbers. Staff can only associate the slight fall back to the slow start of the spring/summer season, fuel and inflationary costs limiting discretionary spending. Personal Property Replacement Taxes continue to be strong and trending nearly three times higher than appropriated. Property tax distributions continue with another significant distribution due in late November. Expenses continue to be on par with appropriations as well as salaries. No major repairs to equipment or infrastructure have been required in the General Fund at this time, however the Zoo has had a couple unforeseen expenses totally more than \$20,000. Recently some significant work was required at the giraffe barn and several months ago the fire alarm system in

THIRD PUBLIC MEETING HELD FOR I-80 MISSISSIPPI RIVER BRIDGE STUDY

Narrowed list of bridge and interchange alternatives presented; public input sought

The Illinois Department of Transportation, in partnership with the Iowa Department of Transportation and under the jurisdiction of the Federal Highway Administration, hosted a third online Public Meeting on Thursday, October 27, 2022, to provide study information, present a narrowed list of improvement alternatives, and receive public feedback as part of the I-80 Mississippi River Bridge study.

This early-stage transportation study was launched to coordinate with stakeholders to identify existing and future transportation problems and needs in the area, with the project's purpose and need used to develop proposed improvements, or "alternatives."

The study area reaches from Rock Island County, Illinois to Scott County, Iowa, covering approximately six miles from the I-88/I-80 interchange in Illinois to 35th Street SW in LeClaire, Iowa, and including the bridge connecting the states over the Mississippi River.

The I-80 Mississippi River Bridge was built in 1967 and is one of three major interstate bridges in the Quad Cities. The bridge has required significant repairs and rehabilitation in recent years and traffic is increasing with associated increases in vehicular crashes. The aging bridge continues to face costly maintenance expenses, and the roadway design does not meet current standards.

In April 2020, the state departments of transportation held an online public meeting to introduce the planning study and seek public feedback. More than 500 residents, organizations and other stakeholders participated, submitting more than 125 questions and comments that were considered in creating the project's purpose & need statement, and developing improvement alternatives.

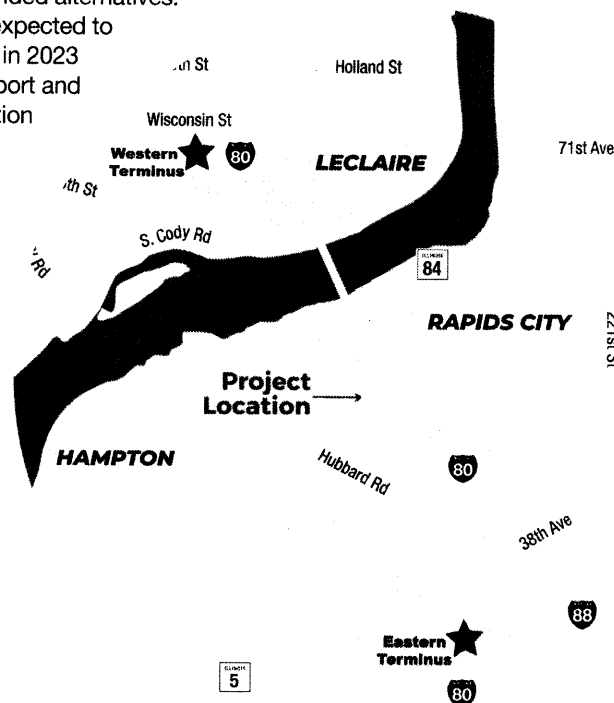
A second online public meeting was held on May 11, 2022 to present seven Mississippi River Bridge and four I-88 Interchange improvement alternatives, and receive public feedback. More than 400 participants attended the meeting, with more than 370 questions and comments submitted during the meeting comment period.

Based on public feedback and additional study, the list of bridge and interchange alternatives was narrowed and presented at the third online public meeting on October 27, 2022. Specifically, four River Bridge alternatives and three Interchange alternatives were recommended to move forward in the process.

Public input is critical to the study. The public is encouraged to visit i80mississippibrIDGE.com to view a recording of the public meeting, review meeting materials and other study information, and submit questions and comments. Comments are always welcome, and those received by November 10, 2022 will be part of the public meeting record.

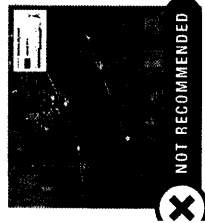
Public feedback and additional study will be considered to further evaluate the recommended alternatives.

The study is expected to conclude late in 2023 with a final report and recommendation of a preferred alternative.

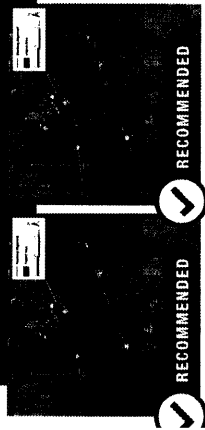

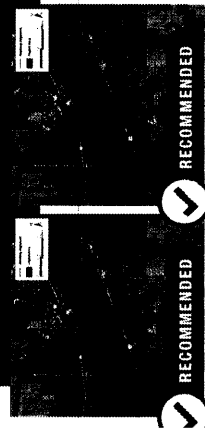

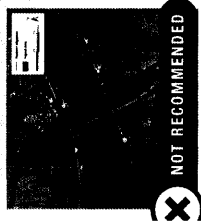

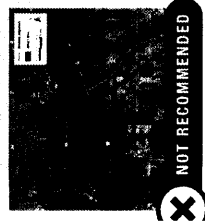
