2. President Swanson stated, "Thank you very much, Madam Clerk. And now, it's my pleasure to introduce to you, the Superintendent of Indian Bluff Golf Course. What we try to do is have presentations by our professional staff to let you know what's going on and to make sure you have a good fix on the strategic issues facing all of the District. And so, with that...Mr. Verstraete, the floor is all yours."

Mr. Verstraete stated, "Thank you much, I am James Verstraete. I am the Superintendent at the Golf Course out at Indian Bluff. I was here not that long ago, maybe in either March or April this spring...and for the ones that were there, some of this might be a repeat but, I see some new faces for sure. We have a lot going on...as a matter of fact, we have some pretty big projects coming up. If you have a little bit of money that you can provide us, we have to shore up some erosion issues happening between our 6th green and 7th tee. It's not too often that you'll hear about problematics. We had an engineering company come in and they graded and took sights and everything of the area...they definitely needed to be done. That's going to be starting here in the next few weeks. Then, our 18th hole out there, we are going to do some aesthetic projects out there. We are going to rake the pond at the lower level out there...we have to get rid of a lot of silt that has kind of filled in over the last 60 or 70 years since the last time that was done. That's going to be well-received by the players. That's going to change the look of the finishing hole and going forward, and having a little retention pond along on the opposite side of the pond that is actually played and hopefully, will not be a problem in the future. They designed it right and hopefully, they execute it right. And then next spring, it's going to have a little bit different look and hopefully get some returning customers something different to look at. It's been a great year for golf too. We had almost no rainouts. The people were just out there like crazy. I know we had some record months for revenue generation, park usage and things like that. And so, it definitely was a positive year even though it was really hot and so the irrigation system held up all the way up until three weeks ago when I had a very important part fail, just three days after I airified the greens; which was perfect timing. But, it got fixed really quick. There is a company that

takes really good care of us...they were 'Johnny on the Spot' for us. And so, it was actually tough to get the component, but happened to have one sitting around. And so, we lucked out. It's been really good...that's 2023 in a nutshell. So, hopefully, next year is even better. Like I said, there are some familiar and new faces...so, come and check us out and let's play some golf. There is definitely a lot going on."

Commissioner Simmer was recognized.

Mr. Simmer stated, "Again, I just wanted to point out a few things about the course out there...you guys always have it looking nice. Some of the private courses, there is no...you gotta have quality when it comes to that stuff."

Mr. Verstraete answered, "Yeah. We have a great crew out there. You get a bang for your buck, it's hard to beat for what it is. It's an old golf course...it has lots of mature trees on it and some varied landscaping. A lot of you may not know, there is a section of the Sauk Fox Trail left out there that was used by the Indians about a little less than a thousand years. So, they did really change the grading of the land up there, it has lots of natural silt. It's a pretty neat place. If you want to go out...find me and we'll go for a ride, play some golf."

President Swanson asked, "Are there any other questions? There is one I had Jay...if there are things that we need to be thinking about that we might need over the horizon, strategic issues or anything that you think we need to be keeping an eye on right now or even 12-18 months from now?"

Mr. Verstraete asked, "Uh, project-wise, we need to redo the parking lot and the roadway going all the way over to the maintenance facility and into some of the park area is really in need of being replaced. It's completely saturated and crushed from years of frost and heat cycles, heavy equipment and light equipment has taken its toll on it. So, that's going to need...the whole parking lot needs to be completely redone. It was all fill to begin with 50 or 60 years ago...whenever they started building it. It was over ravines that have settled over time...it's the nature of the beast. That's the biggest thing, I would say. After we will be addressing the project on the 6th. If you guys ever want to give me a lot of money, I would like to redo the tee's out there. Some of them are over 100 years old. The grass gets tired after a while. It really does, all joking aside...the nuchal bars of grass, they kind of breed in and lose heat and frost resistance and things like that and so...it does reduce your pesticide usage going forward...once you commit to spending a little bit of money on that kind of new stuff, it's totally necessary. Well, not really but it is nice because the customers would notice it. But, I would think the most immediate thing is definitely the parking lot."

Commissioner Simmer was recognized.

Mr. Simmer asked, "How are we on the life of our carts? Where are we at for the cycle?"

Mr. Verstraete answered, "Of carts?"

Mr. Simmer answered, "Yeah."

Mr. Verstraete answered, "Uh...I think we might be due to be trading them in...in about one more year. Uh...Jeff do you have anything on that?"

Jeff Craver answered, "They went out for bid and you won't get them until early next year."

Mr. Verstraete stated, "Yeah. That's depending on availability."

Jeff Craver stated, "It's actually early 2025. We would have gotten them next year, but we...because of the back order of all three manufacturers, they are back ordered. It will be the spring of 2025, when we get them. Initially, the first round of carts, we kept for about eight years and that was too long. Back then we had to deal with some other issues, and so we tested the market a few years ago with the trade-in a little bit earlier and it worked out pretty well for us. I think our trade-in...the carts as well as everything else, obviously that has increased. I think we got almost 70-80 percent of the cart value rate that we bought them for five years ago. And so, it's a good system that we have."

President Swanson stated, "So, for newer Commission Members, we didn't always have that system and it was when it was no longer going to drive, we would do the replacement. But Jay and Jeff and the team have been a lot more methodical of looking over the horizon when something has got to go and they kind of schedule it that way. That's also why...Dr. Simmer, with the way...we are still going to be alright."

Jeff Craver, Director of the Forest Preserve was recognized.

Mr. Craver added, "When looking on the horizon, with maintenance we are getting close to 20 years on the Clubhouse crew...uh, believe it or not. Um, another thing that is on the radar not necessarily totally in Jay's corner, would be the Snack Shack out there. Jay and his crew have done some face-lifts...I guess, if you can on...how old is that structure out there Jay?"

Mr. Verstraete answered, "On the Snack Shack, I would guess 50 or 60 years old is my guess. It might have even been before that. It's all cinderblock and cement."

Mr. Craver added, "Yeah, the Snack Shack needs a little bit of love and the roads all the way through."

Mr. Verstraete added, "And, the bathrooms on 10...were probably built at or about the same time."

Mr. Simmer asked, "Do we have any more vandalism back there? I know we had some problems for a while here with kids and some vandalism out there. Has it pretty much stopped?"

Mr. Verstraete answered, "For the most part, yeah. It is not as consistent as it was."

President Swanson asked, "Are there any more questions for Mr. Verstraete? Oh-, please, Mr. Brunk."

Mr. Brunk stated, "So, if we were to organize a Commission outing, do you still have the duffer award?"

(Group Laughter)

Mr. Verstraete answered, "Oh yeah, it's a can a chili with a little statue on top."

President Swanson stated, "If we were to start that today, I would finish the course in about three weeks. Let's put it that way, Mr. Brunk. Ah any other questions for Mr. Verstraete? I just want to thank you and your team. As I already mentioned, you and your team...I don't golf myself, but I always ask golfers what they think and the thing that I heard more commonly than anything else is, it's the best maintained golf course in the Quad Cities."

Mr. Verstraete stated, "We have a great crew that take on private jobs."

President Swanson asked, "So, would you please join me in thanking Mr. Verstraete and his team. Thank you."

(Group applause)

President Swanson added, "Alright, well friends...next on our agenda and thank you for taking the time to be with us, Jay. I would entertain a motion to approve the August Commission minutes."

Mr. Craver stated, "If you don't want to buy tickets, but would like to volunteer, come see me after the meeting and I will get you in contact with a volunteer coordinator."

President Swanson added, "I know we have some long-serving volunteers right here in this room and Edna can tell you all about that. I hope you get a chance to enjoy it. Plus, right now, with the things that are going on there...if you have a chance to otherwise support the zoo. It's a great time to do so. We are just about...well, we will get to those reports in a little bit. I appreciate the way the zoo makes it fun to support them. And so, I hope that I will see a lot of you out there on Friday night. It will be a great time because it always is. Thank you, Jeff, for those reminders. Alright, you will have time for questions on reports and so forth a little later on in the agenda."
