President Swanson called the monthly meeting of the Forest Preserve Executive Committee to order at 9:35 AM on Tuesday, January 14, 2025, in the second floor conference room of the County Building in Rock Island, Illinois.

President Swanson called for a motion approving the December Committee meeting and the closed session minutes.

Mr. Craver added that hopefully will get Bids out and back by May of this year.

President Swanson called on Mr. Craver for the discussion of Electric Vehicle Charger assessment report for the District.

Mr. Craver stated that District was award up to \$410,000.00 for installation of electric vehicle charging station at the various facilities. This gives us some nice cost estimates. There are a couple of different options for several of our facilities. Looking at three stations at Loud Thunder. Four at Niabi, which would be eight ports. At Illiniwek there are a couple of different options as well. Such as a spot near the restroom facility, or a spot across the road. There is space for some station in the Amôwa parking lot, and even at Dorrance and the Martin Conservation area. Electric vehicle charging stations are not in great demand at this time, but in the foreseeable future hopefully they will be a great amenity that is offered at District facilities. It is a 20% match grant. There is also the added bonus of getting more electric infrastructure out at the preserves in areas that would benefit the District beyond powering the stations.

President Swanson stated that this did sound like an excellent opportunity for the District.

Dr. Moreno stated that he agreed. It does sounds like a great opportunity. There is one concern that I have. Around the country in remote and isolated locations that have charging

station there have reports of vandalism and theft of copper from the stations. Are there plans to put security cameras out at those locations?

Mr. Craver stated that that's a possibility. While there have been instances of vandalism, and theft, at the preserves, it tends to be few and far between. However, more security would be another bonus to the project.

Mr. Mielke asked if the charging stations would be 24/7.

Mr. Craver stated that the stations would only operate during park hours.

There was a brief discussion on the future of electric vehicles in this country.

President Swanson asked Mr. Camlin if there was anything he'd like to bring to the Committee's attention.

Mr. Camlin stated that he had received 6 bids for the Tax Anticipation Warrant for Niabi. These still need thoroughly compared to ensure that the best deal for the District is chosen, but there are a couple bids that look good.

President Swanson asked Ms. Palmer if there was anything she wanted to bring to the Committee's attention.

Ms. Palmer stated that there was nothing specific. The District is half way through its fiscal year, and the budget is looking as expected.

President Swanson asked Mr. Collins if there was anything that he wanted to lift up from his report.

Mr. Collins stated that this was an excellent year for the golf course. Even better than last year, and that's saying something.

President Swanson asked Mr. Mills if there was anything he wanted to lift up from his report.

Mr. Mills stated that, as specified in the report, staff is working on winter maintenance, pesticide licenses, and the forest management plan when weather allows.

President Swanson asked Mr. Craver if there was anything that he wanted to bring to the Committee's attention.

Mr. Craver stated that Mr. Jackson is on vacation. There was an application submitted for zoo exhibits, so hopefully the District will get that grant.

President Swanson called for a motion to approve all routine reports from the Director and Department Heads as presented.

MOTION: Mr. Mielke moved to approve all routine reports from the Director and Department Heads as presented. Dr. Simmer seconded the motion.

Motion carried.

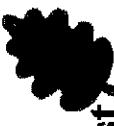

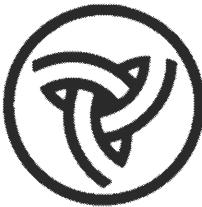

Impacts to public recreational lands require coordination and concurrence from the Official with Jurisdiction in accordance with Section 4(f) of the U.S. Department of Transportation Act of 1966. This process and the concurrence we are seeking are further described in this letter.

Project Background

IDOT has been studying potential improvements to the I-80 Bridge over the Mississippi River. The I-80 Bridge is a critical transportation link providing access across the Mississippi River for Rock Island and Scott counties, and the surrounding region.

The Phase I study has advanced to the point where the Preferred Alternative has been selected. The Preferred Alternative would involve the replacement of the I-80 bridge across the Mississippi River, reconstruction of the US 67 and IL 84 interchanges on both ends of the bridge, reconstruction of the I-88/I-80 interchange, and associated improvements along the I-80 mainline. Several alternatives were evaluated to provide the least amount of impacts, as well as provide a structurally sound and safe crossing over the Mississippi River.

Forest Preserve Impacts

The potential impacts to Amowa Forest Preserve are related to I-88 interchange modifications required to address existing geometric deficiencies that contribute to safety issues. The proposed improvements would impact approximately 3.5 acres in a linear strip of undeveloped land along the existing I-88 interchange right-of-way. The entrance to the preserve would not be directly impacted but access to the preserve south of the entrance via Hubbard Road may be temporarily impacted during construction due to the relocation of Hubbard Road. Although there was no feasible and prudent way to entirely avoid impacts to the Amowa Forest Preserve, efforts were made to minimize the impacts to this property. These Section 4(f) impacts and mitigation measures will be documented in the Phase I Engineering Report as part of the Categorical Exclusion.

Amowa Forest Preserve is considered a Section 4(f) resource by the Federal Highway Administration (FHWA). Section 4(f) refers to the original section within the U.S. Department of Transportation Act of 1966 which provided for consideration of park and recreation lands, wildlife and waterfowl refuges, and historic sites during transportation project development. The law, now codified in 49 U.S.C §303 and 23 U.S.C. §138, applies only to the U.S. Department of Transportation (U.S. DOT) and is implemented by the Federal Highway Administration (FHWA) and the Federal Transit Administration through the regulation 23 Code of Federal Regulations (CFR) 774.

Before approving a project that uses Section 4(f) property, FHWA must determine that there is no feasible and prudent alternative that avoids the Section 4(f) properties and that the project includes all possible planning to minimize harm to the Section 4(f) properties, or FHWA makes a finding that the project has a de minimis impact on the Section 4(f) property.

A de minimis impact involves the use of Section 4(f) property that is generally minor in nature. A de minimis impact is one that, after taking into account avoidance, minimization, mitigation and

enhancement measures, results in no adverse effect to the activities, features, or attributes qualifying a park, recreation area, or refuge for protection under Section 4(f). A de minimis impact determination requires agency coordination with the officials having jurisdiction over the Section 4(f) property and opportunities for public involvement. Because the impacts to Amowa Forest Preserve are considered minor to the overall functionality of the Preserve due to the small percentage of impacted area, IDOT has prepared the attached Section 4(f) documentation (see attached). A public hearing was held on October 29, 2024 (online) and on October 30, 2024 (in person), and the public had the opportunity to provide comments on the project and the impacts to Duck Ranch. No comments were received regarding Amowa Forest Preserve.

Conclusion

IDOT recommends that the proposed impacts to Amowa Forest Preserve are consistent with a de minimis impact for the use of a Section 4(f) property and will not adversely affect the features, attributes, or activities qualifying the property for protection under Section 4(f) of the U.S. Department of Transportation Act of 1966.

The purpose of this memo is to document coordination with the Rock Island County Forest Preserve District officials, having jurisdiction over the Section 4(f) property, and gain their concurrence that the proposed minor impacts to the Amowa Forest Preserve will not adversely affect the activities, features, and attributes which qualify the resource for protection under Section 4(f).

Grounds Maintenance performed— Staff installed gates at the sledding hill to prepare for snow and sledding season. Staff started cutting trees out of the prairie at Amowa east. Tree removed were non native white mulberry, Siberian elm, and tree of heaven. Trees were piled into brush piles that will be burned sometime in February. Staff started removing and trimming trees in the campground at Illiniwek. Two large Siberian elms were removed off electric site 3 and 5. Staff also finished cleaning up flood debris around the boat ramp parking area. Mostly logs that floated in during high water. Trees around the boat ramp parking lot that were leaning towards the parking lot were removed. 9 dead ash trees were removed in this area as well. 12 white mulberry were removed in the woodland west of the pavilion and 2 dead elm trees were removed along the river along with 1 dead cottonwood. Staff borrowed the stump grinder from Loud Thunder and have been grinding stumps in the 9th street project and in the campground. Staff hauled 500 gallons of water over to the campground to dump into the lift station pit. For some reason the pumps went into backup mode and the only way to fix this problem was to cycle the pumps. System is now operating correctly.

Building Maintenance projects performed—No building maintenance this month.

Equipment repairs and/or project performed— The 2018 F-150 door locks were fixed as part of a Ford recall. The doors would not latch shut. The 5225 John Deere tractors 4 wheel drive shaft was replaced along with the wiring harness that activates the 4 wheel drive.

Trails/Course/General facility conditions—The trails at Illiniwek, Dorrance, and Amowa are in good shape. Closed a few times in January for soft and muddy conditions but in general have been open and used a lot.

Weather conditions— The month of January was extremely cold. Temperatures were extremely cold for a significantly longer period than we typically see this time of year.

Activities/Events/Outings held at park— The Loud Thunder Deer Archery Hunt is done for the year and a total of 35 deer were harvested this season.

The month of January was a productive one for staff here at the preserve. We were able to remove and replace two decks on our small pontoon boats for the boat rental, and work on other annual maintenance during the bitterly cold days where working outdoors was tough. Staff also finished up pruning operations along with removals of several hazard trees on the grounds. I still have a few trees that I will have staff remove prior to the 2025 camping season to mitigate risk. we will process these trees into firewood to sell to our campers.

Recent lake and fish studies conducted by IL Fisheries biologist have recommended the need for additional habitat for a few years. I am pleased to inform this committee that our application for installing fish habitat has been approved by the U.S. Corps of Engineers, and this spring, David Wyffles with the IL DNR Fisheries, will be placing 5 structures in Lake George. Caleb Cox built these structures for his Eagle Scout project fall of 2024. I may have staff construct an additional 5 or 10 structures if time permits after all normal winter maintenance is complete as the biologist feel more would be additionally beneficial to the fishery.

Sustained cold temps that we experienced during the month of January kept patrons from visiting the preserve. This decline is pretty typical for this time of year, and can turn on a dime as soon as temps are forecasted high 30's and above. Ice fishermen have been taking advantage of Lake George being frozen, and fishing reports have been very good for panfish. Other users who have continued to come out include a few committed hikers and people walking their dogs.

Jeramy Duffee has again reached out to me to ask permission from this committee to hold the 4STA race here at the preserve this fall. His request is attached below in my report. I have had no problems working with him in the past and recommend granting him permission. He knows that he must provide proof of insurance of no less than \$1,000,000 and list Loud Thunder as "additionally insured", and run any changes to the race through me.

Finally, I and staff have received complaints consistently through the years in regard to the hard water smell from patrons in our new campgrounds. I have brought Oak Plumbing into the preserve to aerate the new well that provides water for both Deer Haven and the Horse Corral campgrounds. There is a very good chance that doing this may completely eliminate the sulfur smell in our water. If this is not successful then I will have to look into treating the water to eliminate this smell and that would be an ongoing operating cost to the district. I will follow-up with this committee when the job is complete and let you know if it was successful or not

In general, throughout the District January operations were typical in nature with routine maintenance and repairs being conducted on equipment. January was fairly cold with day time temperatures below freezing and at times bitterly cold in the single digits, but I guess it was better than 2 feet of snow like last year. If you recall the two storms did a substantial amount of damage to the exhibits at the zoo. The extreme cold events slowed staff from typical outdoor work activities during those periods but with frost in the ground and little to no snow fall predicted in February they should catch up on those activities. Park use has been typical with the daily regular hikers and some ice fishermen. The state deer season concluded in mid-January which brought the Loud Thunder archery program to an end. The zoo held a few educational sessions. There was no activity at the golf course. Staff will continue with winter operations and activities into February and looking forward to spring.

Budget Performance Report

The FY 25 Budget Performance Report as of the close of business for January 31, 2025 is enclosed for your review. Both revenues and expenditures continue to occur as originally adopted other than the decrease funds in Personal Property Replacement Taxes and increase in Interest earned. Niabi Zoo Fund revenues are below the pace of appropriations if using prior years receipts as a comparison.

- Union - One grievance was received by the District from the Union in the month of January and then withdrawn. A prior grievance was moved to step 2 and will be heard by the grievance committee in February. The union requested a demand bargaining session over some changes to phone use policies at the zoo.
- A retired employee, Dale Salisbury, filed a claim against the District with the Illinois Workers' Compensation Commission.
- Submitted sales tax reported for the month of January.
- Staff met with representatives from IMEG to explore additional access points to Lake George.
- Staff met with representatives from Estes Construction to review repairs and upgrades to the residence at Loud Thunder Forest Preserve.

- Work continues on the exhibits at the zoo that received snow damage last year. The work has been slow and held up by the structural engineers, weather and unforeseen utilities in the project area. A water conditioner was added to the cathouse to treat the well water which should help improve the water lines and overall effect the water has on the interior structures that are clean daily.
- Submitted a claim on the District's behalf to the Illinois State Treasurer for \$1500. A credit balance from Sunbelt Rentals was never captured.
- Participated in IACD 2025 conference planning meeting, the conference is to be held February 20 & 21 at Starved Rock Lodge.
- A list of IL DNR grants available was released and staff are reviewing possibilities. Unfortunately, the state is not funding the Illinois Public Museum grant again.
- Cardpointe, the District's credit card processor Payment Card Industry (PCI) annual security evaluation was scheduled and completed.
- Vermont Systems, the District's point of sale software in January had a brute force attack in which thousands (like close to 50,000) of credit card numbers were ran through the system. Most of the transactions were less than 10 cents, however the credit card processor charged us for the use and staff are in the process of rectifying that.
- Staff have been working on annual items such as the campground, liquor and amusement ride licenses for the year.
- The District had four insurance policies pertaining to the fuel stations of the District. As of January 2025, those four policies were combined into one.
- IPARKS put the District on notice that beginning in 2026 policy terms will be aligned with the calendar year. Currently the District's policy term is August 1 to July 31. The next renewal in August of 2025 the District will be billed for August to December of 2025 and then billed again for the 2026 calendar year. This will put a little pressure on the cash balance in the Liability Fund and even more so now that the District has an existing workers compensation claim. Reserves in the General Fund will be able to cover any necessary cash flow issues within the fund.
- Submitted receipts to IPARKS for the golf course clubhouse lighting strike incident that occurred last July. The clubhouse incurred \$11,194.70 in damages, all were electrical related. The District's deductible is \$5000.00.
- Registered to keep the District's System for Award Management (SAM) and other federal requirement in tact for potential grant opportunities in December. Currently the District's GATA account is active and up to date with FY 24 audit information currently under review.

- Participated in a review of the District's ratings with Moody's.
- Used a couple days of vacation throughout the month indulge in some winter activities and intend to do so again in February if the weather cooperates.
- Will be attending the IAPD Joint Legislative Committee Breakfast in Princeton on February 13th at 8:30 AM.
- President's Day Holiday February 17.

Inspection Recommendations and General Comments

Dam ID No.: IL00136

Name of Dam: Lake George

Owner: Rock Island County Forest Preserve District

Recommendations to be completed by December 2025:

1. **Maintain a mowed downstream embankment for inspection.** Vegetation should be maintained to a length where the grass will not fold over on itself, this will allow for proper inspection. Visual inspection of the embankment is very effective and is one of the easiest and best warning signs to determine any potential stability concerns or other possible issues (e.g. seepage or piping issues, rutting, burrows). Vegetation to be burned or mowed on downstream slope. Remove woody vegetation from embankment and downstream energy dissipater.
2. **Repair downstream erosion from roadway.** The rock drain near station 12+25 LT was observed to be further eroded, compared to prior inspections on the downstream face of the dam. There is now two establish erosion rills to be repaired with compacted soil and erosion control measures.
3. **Complete routine maintenance/break-in of sluice gate.** Follow manufacturer's Operation & Maintenance recommendations and routinely work valve. Remove bird nest on stem guide of valve.
4. **Clear Vegetation** Clear vegetation along spillway chute fence to allow for proper visual inspection and prevent burrowing animals.
5. **Repair fence along spillway chute.**

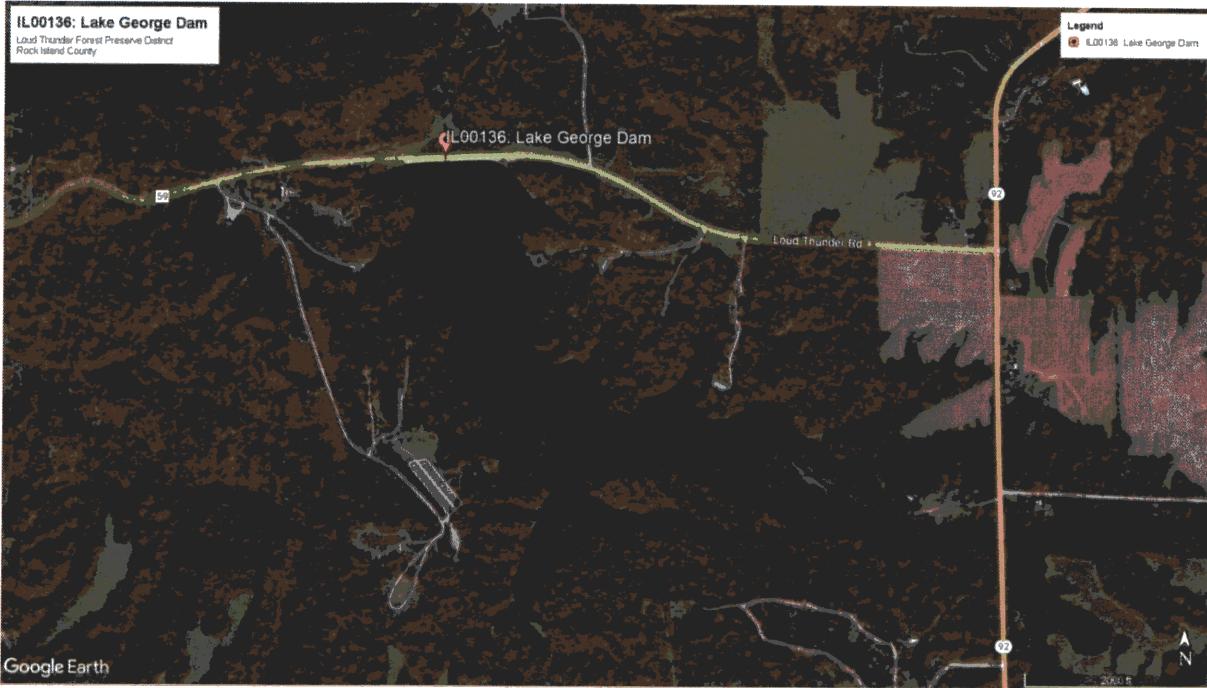


Figure 1: Overall Map (Aerial October 2022)

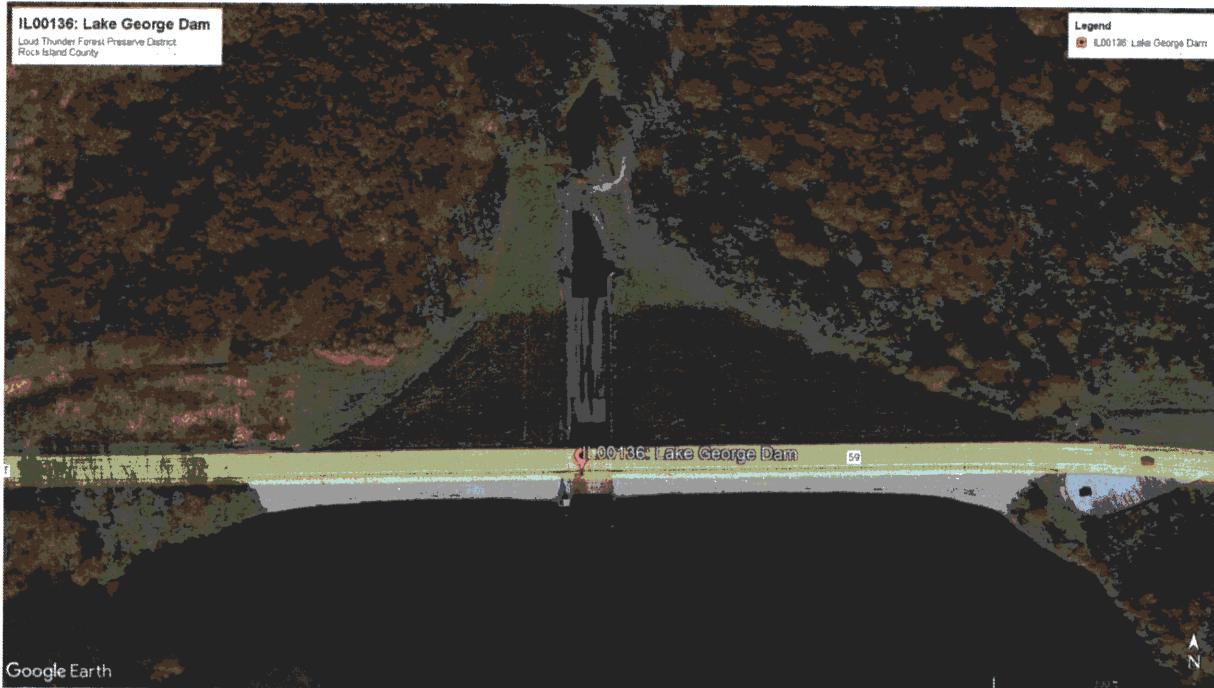


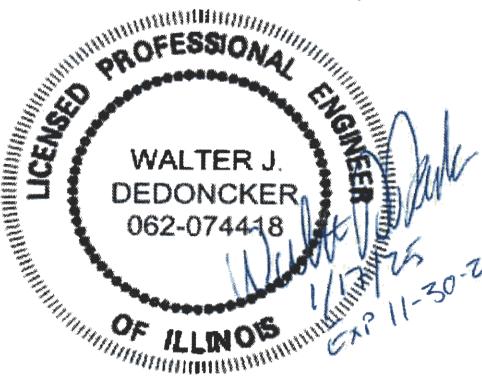
Figure 2: Dam Limits Map (Aerial October 2022)

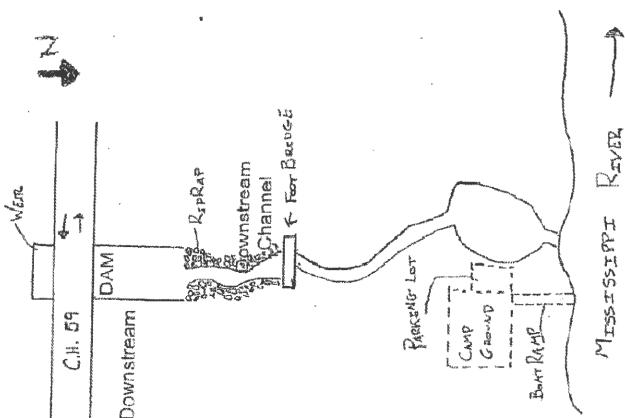

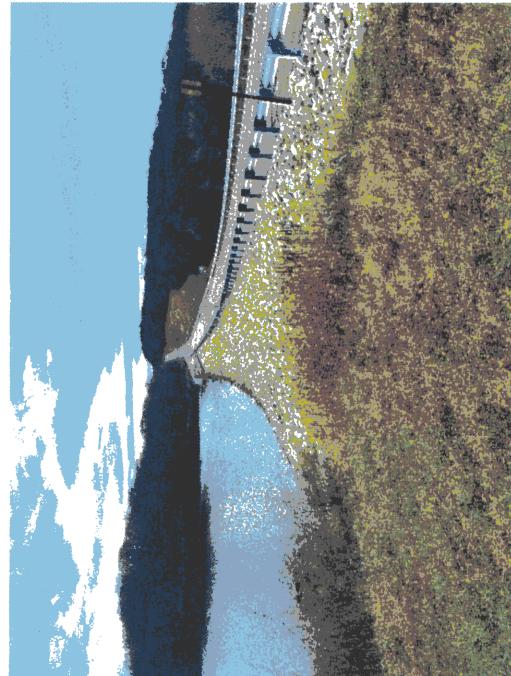


Figure 1: Upstream dam face looking west

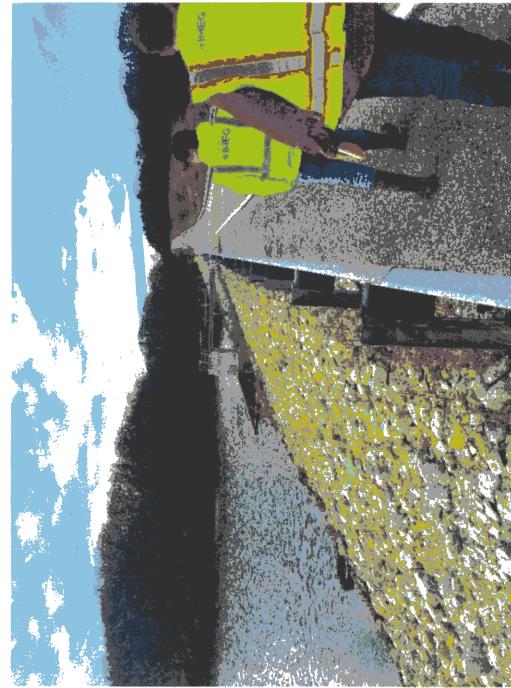


Figure 2: Upstream dam face looking west

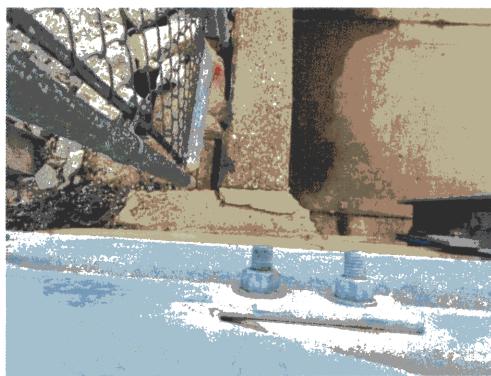


Figure 9: Spall at southeast bridge abutment/spillway wall corner

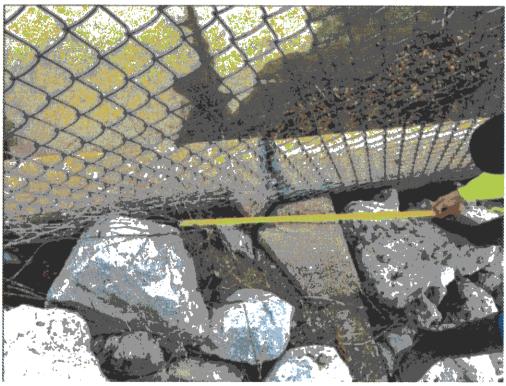


Figure 16: West spillway wall joint A

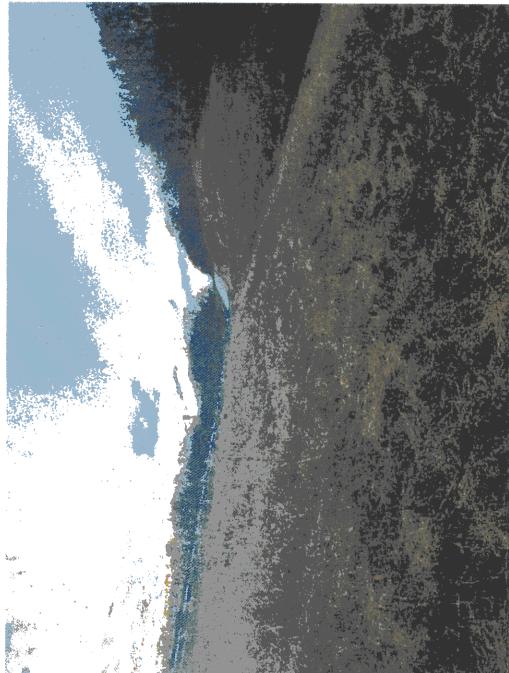


Figure 31: West downstream

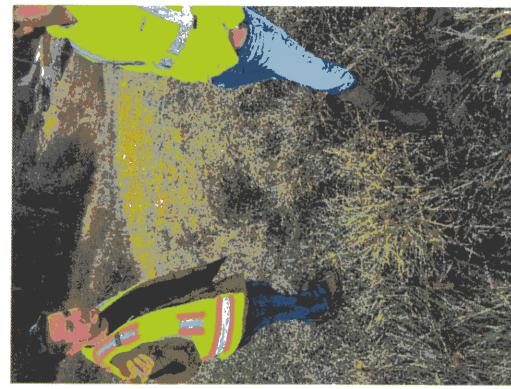


Figure 30: Adjacent erosion, west of spillway

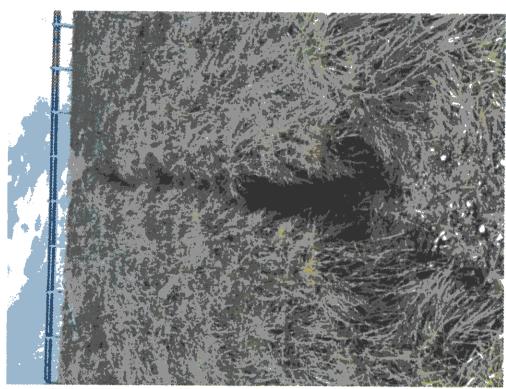


Figure 32: Continued erosion at downstream face, west of spillway

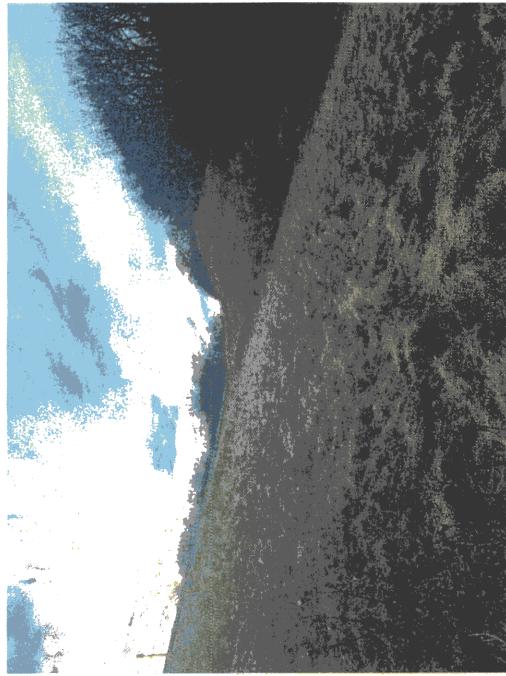


Figure 34: Downstream face looking west

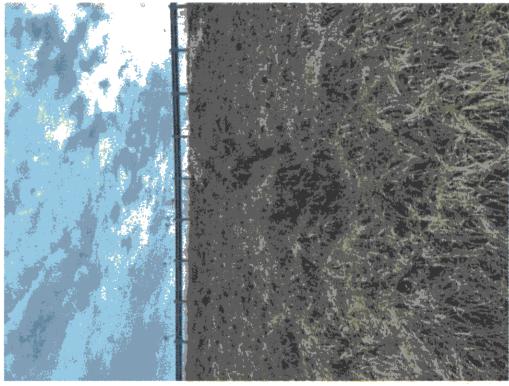


Figure 36: Typical trails along spillway looking south

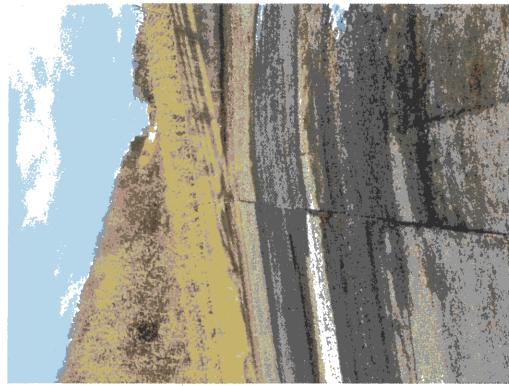


Figure 44: Spillway wall elevation at joint E

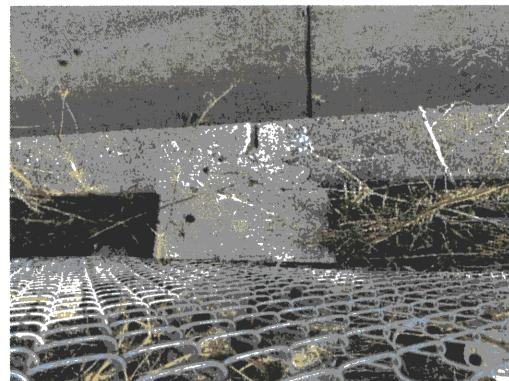


Figure 45: West spillway wall joint F

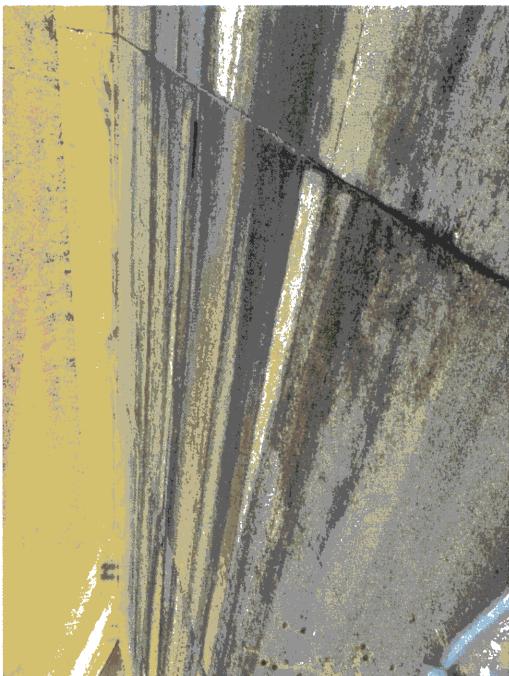


Figure 47: Transverse cracking in span F-G

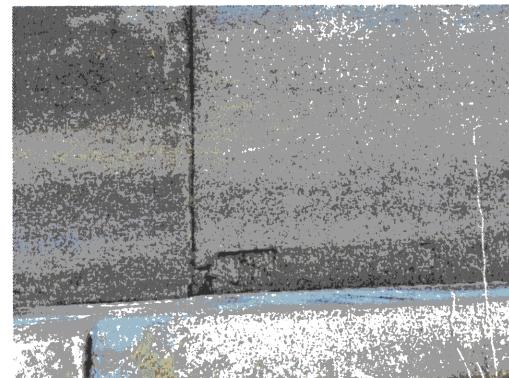

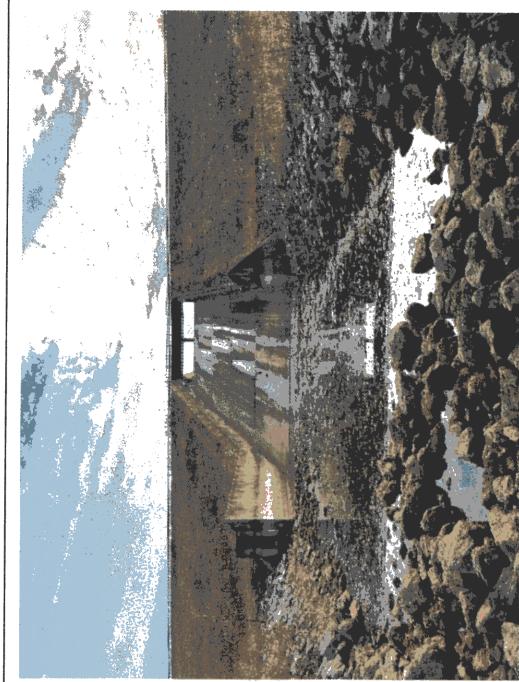


Figure 54: Downstream elevation

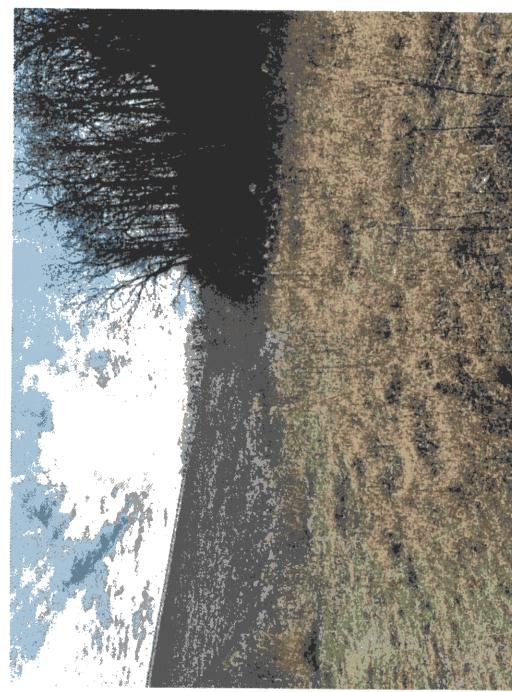


Figure 56: Downstream face looking southwest

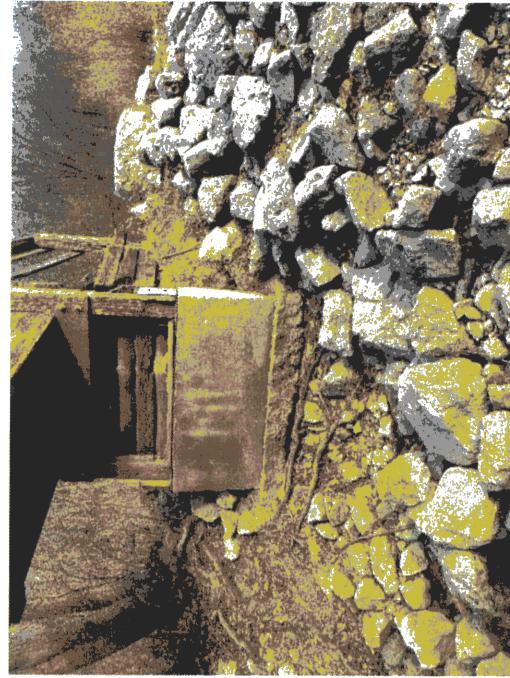


Figure 57: Pedestrian bridge substructure exposure

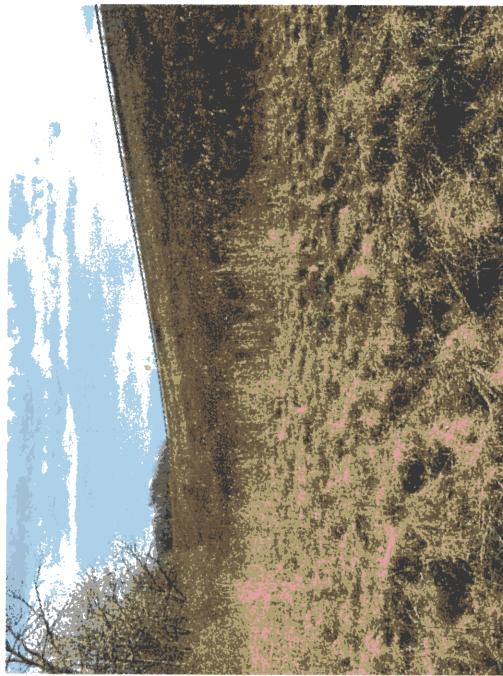


Figure 62: East toe looking east

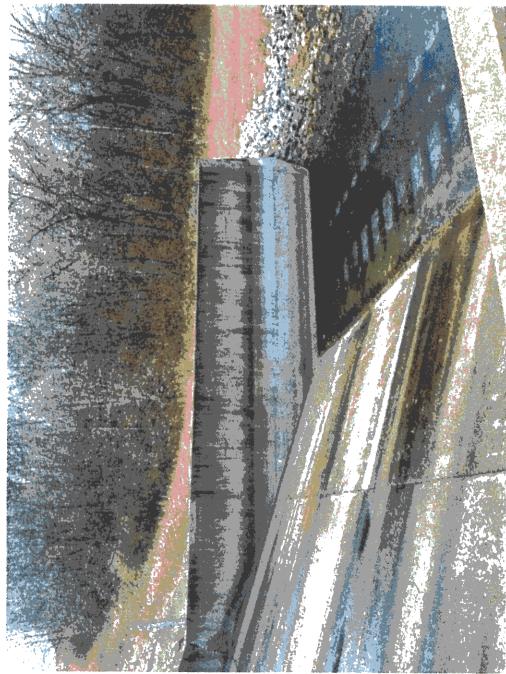


Figure 64: West spillway wall elevation looking west

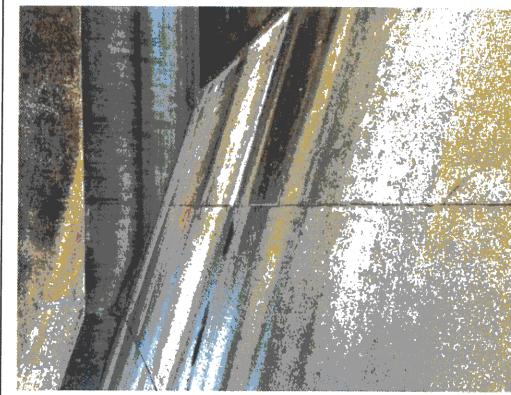


Figure 66: East spillway floor joint I

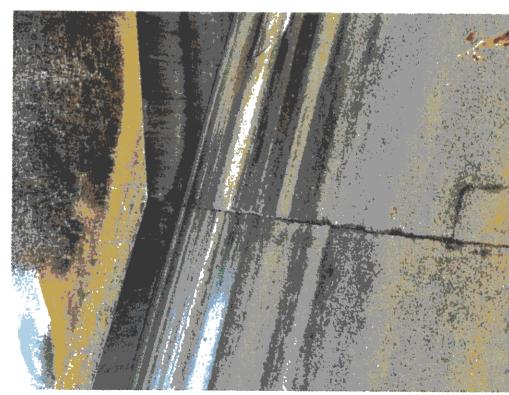


Figure 68: Spillway wall elevation at joint H

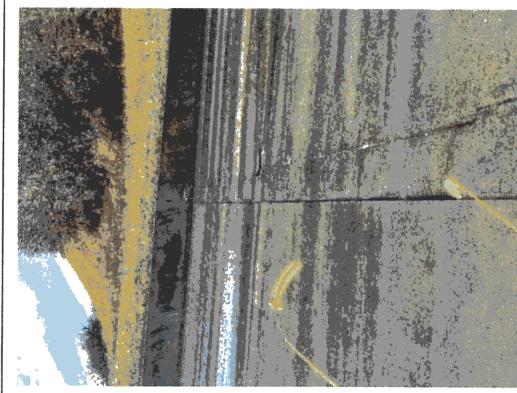


Figure 70: Spillway wall elevation at joint G

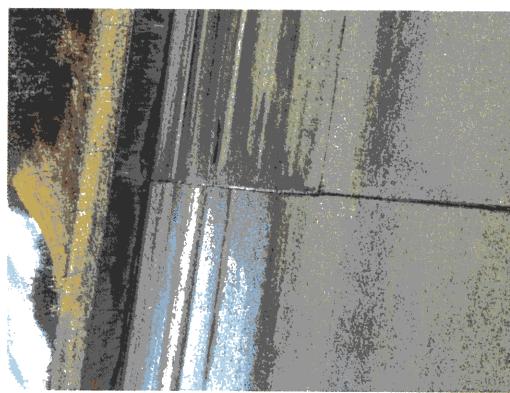


Figure 72: Spillway wall elevation at joint F

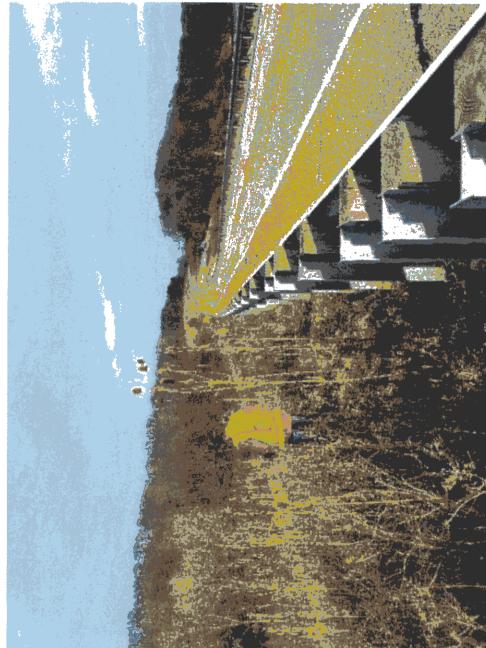


Figure 79: Downstream face looking east

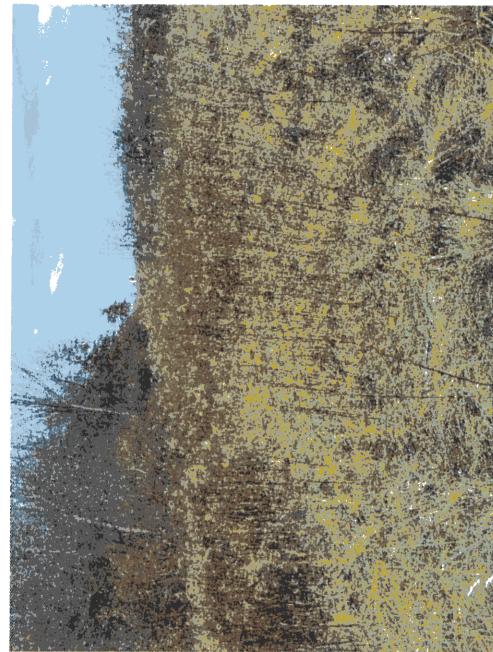


Figure 78: Downstream face looking east

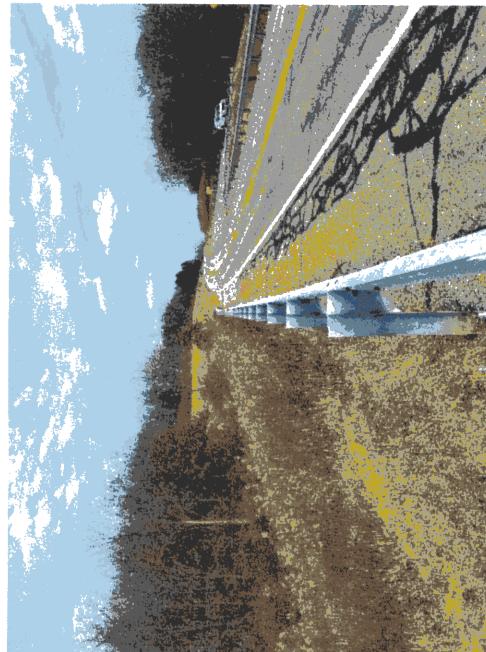


Figure 80: Downstream face looking east
